2023 SCHOLARSHIP APPLICATION

The Grand Court of Ohio, Order of the Amaranth, awards several \$500.00 scholarships annually to qualifying youth. The success of our fundraising determines the number of scholarships awarded. Scholarship applications are awarded for one (1) academic year only.

Please note: Priority consideration is given to students who have submitted and have postmarked the scholarship application by **April 1, 2023**. Applications submitted after this date will not be considered

ELIGIBILITY AND EXPECTATIONS

Applicants must be a high school senior or an undergraduate student of a university, college, community college, or technical college. Applicants who are selected to receive a scholarship will be notified by the first week of May 2023. At that time, we will discuss arrangements for your attendance at the Grand Court Opening Ceremonies on May 18, 2023 at Kalahari Resorts and Conventions in Sandusky, Ohio. If the applicant decides not to attend a university, college, community college, or technical college or is not accepted for the 2023 year, then they forfeit this \$500.00 scholarship.

REQUIRED DOCUMENTS

The following documents must be submitted to the scholarship chairperson in order for you to be considered for this scholarship:

1. **2023 Scholarship Application Form**: See attached form. All application forms must be completed by printing or typing. If a section is "not applicable", please enter N/A.
2. **Transcripts**: High school transcripts (required for all high school applicants). If you have completed advanced schooling, you must submit transcripts from your school(s) from the 2022 school year. If you are unable to obtain a transcript, please secure an affidavit from a school official attesting to your scholastic standing.
3. **Letters of Reference**: Two (2) letters of reference from sources dated in the last year. Neither of these letters are to be from a relative.
4. **Acceptance Letter**: If you have already been accepted to a school, please include a copy of your acceptance letter.
5. **Essay**: Please answer one (1) of the following questions: 1. How will this scholarship make a difference for you? OR 2. What are your academic or professional goals?
