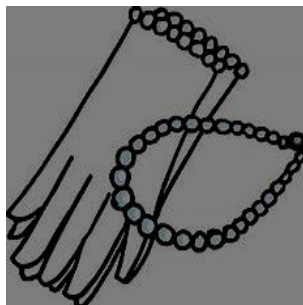

PAGEANT INFORMATION

Pageant Format

During the evening introductions, each Delegate will be asked **an impromptu question** chosen by the Pageant committee from the information on her questionnaire. The auditors will compile scores received for each Delegate. The Finalists will then be announced and taken to a sound proof room and brought back individually before answering the final question. The 2018-2019 Ohio Miss Congeniality will then be announced. From the finalists, the runners-up will be announced and finally, the moment that everyone has been waiting for, the announcement of the 2018-2019 Ohio Miss Job's Daughter.

There will be plenty of adult workers during the day and daughters will be chaperoned as per law. **Only those who are involved with the Pageant and have a badge will be admitted during the day – this includes Daughters, Parents and other adults.**

There will be a luncheon for the OMJD, OMC, POMJD, POMC, delegates, alternates and judges beginning at 12:00 PM. This will be an opportunity for everyone to meet the delegates and alternates!

There will be group pictures taken starting at 5:30 PM. A photographer will be available to take photos of the Delegates and Alternates. Each Delegate and Alternate is requested to be in the group picture. Information on purchasing pictures will be included with the confirmation letters sent to each Delegate and Alternate.

Delegate Information

Each Daughter that is selected to represent her Bethel, as its Delegate, will be judged on the following:

1. The Personal Interview – Each Delegate will have a private interview and will be judged on diction, personality, manners, sincerity, and adaptability to the situation and general impression. **For the interview the Delegates will need to wear a daytime dress or business suit** (no flip flops or sandals). (The length of the interview is to be determined by the Pageant Committee.)
2. The Ritual Competition – **Each Delegate will select, by random draw, one of the 5 Messengers. Drawing will be held during the Open House on Friday.** The Initiatory Lecture is to be given in Official Regalia. Daughters will be judged on accuracy and presentation. Regalia will also be judged.
3. Job's Daughters Written Knowledge Test – General knowledge of the International Order of Job's Daughters Ritual, Ohio Manual of Rules and Regulations, the Constitution and Bylaws of the Supreme Guardian Council.
4. Stage Appearance – Dress will be an evening gown, tea length or longer. (Daughters, no low cut, open-back, strapless, or high-slit dresses or points will be deducted). Daughters will be judged on personality and presentation.

Alternate Information

The Alternates play a very important role in the Pageant. As an Alternate, you will serve as the entertainment. During the day casual wear (no flip flops or sandals). Your evening attire information will be provided to you at a later time.

The Ohio Miss Job's Daughter Pageant will be held on Saturday, April 21, 2018 at the Lakewood Masonic Temple, 15300 Detroit Ave., Lakewood, Ohio 44107.

We will be staying at the Hyatt Place, 2020 Crocker Rd., Westlake, Ohio 44145. This is about 5 miles west of the Lakewood Masonic Temple. There is a swimming pool and Crocker Park (a shopping experience) the Daughters can do during the day if they are not involved with the Pageant.

Room reservations are to be made on the attached form. A check (made payable to "Grand Guardian Council") covering the cost of your room must accompany the reservation form. Only those reservations paid for in advance will be held and guaranteed.

Each room at the hotel is newly remodeled, has a hairdryer, iron and ironing board and coffee pot. Check-in time is 4:00 PM and check out time is 12:00 Noon. **If you are ONLY staying Friday night, you MUST take your belongings with you when you check out Saturday morning.**

The phones, paid movies and room service will be blocked for each room, however if you wish to use these services, an adult will need to make arrangements upon check in.
